



# **Iran allocates** €200m for promoting exports to Africa

TEHRAN - Iran's National Development Fund (NDF) has opened a €200 million credit line for the country's Trade Promotion Organization (TPO) to use for developing exports of commodities and services to African countries.

The mentioned fund has been allocated as part of a \$2-billion support package which has been allocated by NDF for developing the country's non-oil exports, Farzad Piltan, the director-general of TPO's Office of Arabian and African Countries said.

'The board of directors of the National Development Fund has approved this fund and it has scheduled to notify the relevant agencies for its implementation after the plan is reviewed and final-ized in the next meeting of the African

# Virus causes \$5.2 billion damage to Iran's tourism, minister says

TEHRAN - Iran's tourism industry has suffered a loss of some 220 trillion rials (about \$5.2 billion at the official exchange rate of 42,000 rials per dollar) since the outbreak of the coronavirus pandemic, Cultural Heritage, Tourism, and Handicrafts Minister said on Tuesday.

"Iran's tourism has suffered some 220 trillion rials due to corona pandemic so far.... and we hope that with the production of domestic  $% \left( {{{\mathbf{x}}_{i}}} \right)$ vaccines, tourism will flourish in 1400 [the new Iranian calendar year which begins on March 21]," Ali-Asghar Mounesan said.

He made the remarks during the opening ceremony of Tehran's international tourism and handicrafts fair. which is currently underway at Tehran Permanent International Fairgrounds.

"We hope that the widespread vaccine would

such as agritourism, ecotourism, and nature tourism," the minister said.

"Over 1.5 million jobs have been lost in the tourism sector of Iran due to the COVID-19 disease.... Many of the tourism-insiders are now unemployed or they are staying at home,' Mounesan announced last December.

The government had previously allocated a total of 500 trillion rials (about \$12 billion) to the corona-affected sectors, of which 200 trillion rials (\$4.7 billion) will be given to the health ministry and the rest will be spent on other sectors, he explained.

Last month, the minister announced that the national budget bill for the next calendar year (starting on March 20) has proposed 70 trillion rials (about \$1.7 billion) to support tourism businesses affected by the coronavirus pandemic.

## Ma'rib battle: Yemeni army close to retaking city from Saudi-led forces

Victory appears to be on the horizon in the heated battle for Yemen's strategic central province of Ma'rib as army troops, backed by allied fighters from Popular Committees, have reportedly taken control of most areas there and dislodged Saudi-led coalition forces and Riyadh-backed militants from those regions.

A Yemeni military source, speaking on condition of anonymity, told the Arabic service of Russia's Sputnik news agency that Yemeni sol diers and their allies had encircled Ma'rib city, following weeks of fierce clashes with Saudi-led coalition forces and their mercenaries.

The source added that Yemeni forces had cut off the main supply route into the eastern flank of Ma'rib, which leads to the Arab country's largest province of Hadhramaut.

After gaining complete control over all the heights overlooking the city of Ma'rib from all last remaining pockets of al-Qaeda elements and mercenaries of the aggressors (Saudi-led coalition) are only a matter of time," he pointed out. 'Qaeda-affiliated Salafist Islah Party

Meanwhile, the governor of Yemen's southern province of Aden has warned that the al-Qaeda-affiliated Salafist Islah Party is transferring Takfiri militants from southern areas to Ma'rib to join the ranks of Saudi-led coalition forces and Hadi loyalists in battles against Yemeni soldiers and their allies, Press TV reported.

"The Islah Party, which is on the verge of collapse in Ma'rib, is brining Takfiri militants from several regions, mostly from southern provinces under the occupation of Saudi Arabia and the United Arab Emirates (UAE), into Ma'rib," Tariq Salem told Yemen's official

headquarters headed by the First Vice President," Piltan stated.

Holding three joint economic committees and four joint industrial committees with target African countries, holding 10 exclusive exhibitions in 10 different African countries, participation in 10 international exhibitions in African countries, sending 10 trade delegations and accepting 30 trade delegations from African countries, holding 18 trade promotion desks for introducing opportunities and fields of cooperation and export issues are some of the mentioned programs, he explained.

Over the past few years, the Iranian government has been pursuing new plans to promote the country's exports of nonoil goods and services to new markets in order to reduce the country's economic dependence on oil revenues.

In this regard, TPO has played a significant role in supporting the country's exporters and to follow up on the implementation of programs in this field.

### Negotiation with Iran and Turkey is essential: Mohamed ElBaradei

TEHRAN — Former Egyptian Vice-President Mohamed ElBaradei demands Arab countries to forge a regional security system capable of urgently addressing complex relations with Turkey and Iran, according to Anadolu Agency.

In an article titled "Is It Time for a Change in the Arab World?" published on Sunday by Arabi 21, ElBaradei noted he considered dialogue with Turkey and Iran "an issue that cannot be postponed."

"There is a significant need for an independent regional security system that depends on its members and whose capabilities can be trusted to

protect us and our interests, and this system must be able to take the initiative in dealing with complex relationships with our neighbors," stressed ElBaradei, who also served as the director general of the Vienna-based International Atomic Energy Agency from 1997–2009.

Highlighting the importance of negotiations with Iran and Turkey, the former senior Egyptian diplomat said, "In this context, dialogue with Iran and Turkey, with whom we agree on many issues and disagree on a range of others, is something that cannot be postponed." ElBaradei emphasized the need for a "unified and

clear strategy on how to deal with Israel's blatant denial of Palestinian rights", adding that it should start with putting an end to "unnecessary wars and horrifying bloodshed that crushes our people" and instead pursue dialogue to solve "our differences".

He acknowledged that the task will be a daunting one and expressed hope in the "the courage and wisdom" among Arabs to take the first steps.

ElBaradei briefly served as vice-president following Egypt's 2013 military coup, which led to the ouster of Mohamed Morsi, a Muslim Brotherhood leader.

## Joint wind farm to be inaugurated on Iran-Afghanistan border

TEHRAN - Head of Iran's Renewable Energy and Energy Efficiency Organization (SATBA) has announced the inauguration of a huge wind farm project on the border of Iran and Afghanistan in near future, IRNA reported.

According to Mohammad Satakin, 25-megawatt (MW) capacity of the joint project, which is considered one of the biggest wind farms in the world, will be put into operation by the end of the current Iranian calendar year (March 20) while another 25-MW capacity is scheduled to be inaugurated in early next year.

The construction of this 50-megawatt power plant has led to the development of the region's infrastructure such as road construction, the construction of high-voltage electricity lines, substations, as well as telecommunication and Internet infrastructures, Satakin said.

Referring to the eagerness of new investors for the construction of other wind projects in the region, he added: "In addition to this project, another 50-MW wind farm project is under construction using 4.2-MW turbines, part of which will be completed by the end of this year and the other part will be constructed in early next year."

According to Satakin, having 30,000 MW potential of wind power capacity, the Iran-Afghanistan border area is one of the world's most windy regions.

"About 25.000 MW of the mentioned capacity is in the Afghanistan territory while the other 5,000 is on the Iranian side," he explained.

Back in November 2020, Satakin had said that over 30 MW will be added to the country's wind power capacity, of which 60 percent will be supplied by the mentioned wind farm on the Iran-Afghanistan border.

# **Open the window of** rapprochement cautiously

TEHRAN — The Atomic Energy Organization of Iran (AEOI) and the International Atomic Energy Agency (IAEA) made an agreement on Feb. 21 on Iran's parliamentary law in regard to suspending the implementation of the Additional Protocol to the NPT.

Called "Strategic Action to Lift Sanctions and Protect the Interest of Iranian Nation", the law obligates the Iranian government to stop implementing some nuclear commitments. Such a move, which is in line with Paragraph 36 of the JCPOA, sets certain conditions for Iran to reverse its nuclear decisions.

Many experts have shed light on the agreement from different aspects just to indicate that Iran's move in terms of nuclear safeguards seems quite critical.

In this context, on February 22, the Italian Institute for International Political Studies (ISPI) released an opinion piece titled "US-Iran: The Rapprochement Gamble". The analysis was published just on the same day that Tehran and the IAEA concluded the agreement on the Additional Protocol.

The Italian institute focuses on the future of the JCPOA and speculates on "a new window for diplomacy" which seems to be opening between the United States and Islamic Republic of Iran.

The think tank points that Washington has declared that in case of receiving an invitation from the European Union High Representative, it would attend a meeting which is going to be held among Iran, E3 (Britain, France, Germany), China and Russia.

After a virtual meeting with E3, the U.S. stated that it is ready to attend talks with Iran and other major countries to discuss the Iran nuclear deal.

The article argues that such a decision by the Oval Office indicates that the new U.S. administration intends to choose an approach towards Iran that is guite different from its predecessors which were mainly confrontational.

By making such a decision, ISPI argues, President Joe Biden has taken the first tangible step to fulfill his promise to rejoin the 2015 Joint Comprehensive Plan of Action which Trump's administration unilaterally withdrew in May 2018.

Regarding this, the think tank refers to the comments made by some experts on different aspects of the future diplomatic process regarding the JCPOA.

"The U.S.: Symbolic steps for a return to diplomacy" For instance, Barbara Slavin, a senior fellow at the Atlantic Council, believes that although the U.S.'s stated eagerness to attend the meeting "is largely symbolic, (it) can begin the process of ending 'maximum pressure' and returning to diplomacy with Iran - with the European Union as the initial convener.

Expressing hope that Iran would agree to attend the meeting, Slavin stresses: "Regional issues should also be addressed but not in the P5+1 format. The first step is getting the nuclear deal back

#### "Iran's position: Reciprocal, not forthcoming"

To speculate on Iran's likely behavior regarding the U.S. and other parties at the table, ISPI refers to Adnan Tabatabaei, CEO of the Center for Applied Research in Partnership with the Orient (CARPO). Tabatabaei believes that Tehran has no meaningful incentive to "be forthcoming in the quest to revitalize the nuclear agreement." Thus, Tabatabaei argues, "At best, Iran will be ready for reciprocal action the moment President Biden effectively generates immediate economic relief by lifting nuclear-related sanctions and by unfreezing Iran's foreign assets.'

#### "A JCPOA revival will reinvigorate Iranian moderates"

Another analyst comments on future negotiations on the JCPOA with regard to Iran's domestic politics. Abdolrasool Divsallar, a policy leader fellow at the School of Transnational Governance in the European University Institute (EUI), writes that "a JCPOA revival will reinvigorate Iranian moderates." He describes the JCPOA as "a symbol of Iranian reformists' foreign policy achievements" that its collapse will underline "the bankruptcy of a reconciliation narrative with the international system within Iran.'

Moreover, he says, with the June presidential election ahead, a revival of the JCPOA and the Biden administration's clean return to the deal can serve as a game-changer for the reformists to gain the upper hand at the ballot box.

# **Quds Force chief: U.S. only** understands language of force

'U.S. would back off from issuing threats if it were governed by a wise ruling system'

**POLITICAL TEHRAN** — Brigadier General Esmaeil Qaani, commander of the Islamic Revolution Guards Corps Quds Force, says Iran has learned how to deal with the U.S., which only understands the language of force. "Resistance has taught Iran how to speak

with the U.S., which knows the language of force alone," the Quds Force chief told a conference in Tehran on Tuesday.

Pointing to Iran's success in turning threats into opportunities in light of resistance, the commander stressed, "The U.S. would back off from issuing threats if it were governed by a wise ruling system.'

"Whatever threats they (Americans) posed turned into the best opportunities (for Iran)," Tasnim quoted General Qaani as saying

He also referred to Lieutenant General Qassem Soleimani who was martyred in a U.S. terrorist attack in Baghdad in Janu-



ary 2020, saying, "Commander Soleimani was seeking security from day one" and for

10 years he was "directly" in war with the world's monstrous terrorists.

In an address to assassins of General Soleimani, he said, "You are desperate individuals who attributed terrorism to Commander Soleimani and the self-proclaimed defenders of human rights kept silence.'

In comments on February 10, top military adviser to Leader of the Islamic Revolution, Major General Yahya Rahim Safavi, said foreign and extra-regional enemies of Iran, specifically "the triangle of evil, namely the Americans, Zionists, Britons and their regional servants" cannot pose serious military threats to Iran.

In a message marking the 42nd anniversary of victory of the Islamic Revolution earlier in February, Armed Forces Chiefs of Staff Major General Mohammad Hossein Baqeri warned the enemies in the region and beyond of a crushing response they would get in case of military adventure against Iran.

# Nonproliferation experts urge immediate talks between Iran and 5+1

d e s k are calling on the European Union, the United States, and Iran to immediately begin technical talks on the steps necessary to restore compliance with the 2015 nuclear agreement between Iran and the P5+1, according to a press release by Arms Control Association.

The nuclear deal, formally known as the Joint Comprehensive Plan of Action (JCPOA), is endorsed by UN Security Council Resolution 2231.

Kelsey Davenport, director for nonproliferation poli-cy, announced her support for the JCPOA and noted, "We support European Union efforts to immediately convene discussions involving the current parties of the agreement, plus the United States, on the sequencing of the actions that the U.S. and Iranian sides will each need to take to properly implement and restore compliance with the nuclear deal.'

Pointing to the key role of European Union regarding nuclear talks with Iran, she emphasized, "The EU should make clear that these talks are about coordinating the sequencing of the return to compliance and addressing any

**POLITICAL TEHRAN** — Nonproliferation experts technical issues that might need to be resolved—such as the future of Iran's advanced centrifuges not mentioned in the JCPOA—and that this not a renegotiation of the original agreement.'

"We urge Iran and the other JCPOA parties to respond positively to EU-brokered discussions," Davenport remarked.

In a Feb. 1 interview with CNN, Iran's Foreign Minister Javad Zarif suggested that Josep Borrell, the EU's top foreign policy official, could "synchronize" or "choreograph" the moves that the U.S. and Iranian sides will each need to implement to restore compliance with the JCPOA.

The U.S. State Department declared Feb. 18 that "the United States would accept an invitation from the European Union High Representative to attend a meeting of the P5+1 and Iran to discuss a diplomatic way forward.

Meanwhile, Daryl Kimball, executive director at the Arms Control Association, said that "the IAEA-Iran temporary arrangement on nuclear monitoring keeps open the diplomatic window of opportunity to salvage the nuclear deal, but the opportunity will not last."

"To accelerate progress and signal his intentions, we also urge President Biden to state clearly that the United States will remove the sanctions reinstated by former president Donald Trump in violation of U.S. commitments under the JCPOA when the IAEA verifies Iran is reversing its breaches of the JCPOA limits," Kimball added.

He argues the nuclear cooperation between Iran and international community is essential and highlighted, "It is also in the United States interest to immediately waive sanctions on multilateral nonproliferation activities mandated by the JCPOA to convert Iran Arak heavy water reactor. This move would further signal the Biden administration's intentions to meet U.S. commitments under the JCPOA.'

"A return to full compliance with the 2015 nuclear deal by both sides would provide a solid foundation for potential follow-on negotiations on a longer-term framework to address Iran's nuclear program as well as on new, win-win solutions on other areas of concern, such as regional tensions and the ballistic missile programs of Iran and other states in the Middle East (West Asia)," Kimball said.

# Biden's Iran policy is a variation of Bolton's 'Libya Model': Responsible Statecraft

**POLITICAL TEHRAN** – Something d e s k is going very wrong with Joe Biden's approach towards Iran. Unless he corrects the path, Biden risks losing a vital deal and putting the two nations back on a course towards war — at precisely the

time he intends to focus on the multiple domestic crises facing America, according to Responsible Statecraft. In his first month in office, Biden quickly reversed the most damaging of Donald Trump's policies on climate, immigration, health care, and many others. But he has not changed Trump's Iran policy. He has retained all of Trump's sanctions and has not begun the diplomatic exchanges between the two nations that were usual during the last years of the Obama administration, the

American publication writes. Responsible Statecraft sharply criticized Biden's administration for continuing Trump's failed "maximum pressure" campaign, and noted, "Logically and legally, Biden should reioin the agreement he belned craft known as the Joint Comprehensive Plan of Action, or the JCPOA. The current crisis with Iran began when Trump pulled out of the multi-nation accord. Biden harshly criticized Trump's action then, calling it a 'manufactured crisis' that made 'the Ŭ.S., the region and our world less safe." The American publication praised the recent measure taken by Biden's diplomatic team towards Iran and writes, "Biden took the first tentative steps to resume diplomatic dialogue with Iran, agreeing to meet with the

Europeans, China, Russia and Iran and to lift travel restrictions on Iranian diplomats at the United Nations in New York.

Hailing Biden's team due to their diplomatic skills, Responsible Statecraft stressed, "Starting with the president himself, through national security adviser Jake Sullivan, Secretary of State Antony Blinken, Iran Envoy Rob Malley, Deputy Secretary of State-designate Wendy Sherman, Under Secretary of Defense-designate Colin Kahl and more — is highly capable and deeply informed on Iran. They want to get both Iran and the United States back into compliance with the deal that shrank Iran's nuclear program, froze it for a generation, and put it under the most rigorous inspection system ever negotiate.

Pointing to the advantages of the JCPOA for U.S. national security, the American publication underscored, "Until Trump left in May 2018, Iran was in complete compliance with the agreement. Iran had removed over two-thirds of its operational centrifuges, exported all but a token amount of low-enriched uranium, drilled holes into the core of their plutonium reactor and filled it with concrete, and had put all their facilities under cameras, seals, and inspections." Meanwhile, it welcomes Iran's compliance with the nuclear deal and noted, "Iran waited a full year after Trump violated the accord. Then, it took what it says are compensatory steps away from the agreement, but repeatedly insists it will immediately reverse those steps once the United States returns to compliance

by lifting the Trump sanctions." The publication argues Biden's approach on Iran is similar to Trump's and writes, "During the presidential campaign, it seemed that Biden's plan was to quickly rejoin the JCPOA, as he has quickly rejoined other critical arrangements Trump avoided. During the transition, he likely developed a plan to do so. But in the first month, he has made no progress, exchanging his original theory of compliance for compliance" with the mantra that Iran must first come back into complete compliance before the United States moves. This is a variation of John Bolton's "Libya Model." The other side must do everything before the United States does anything."

The Biden team may believe that this approach provides "leverage" and that it can use the so-called "sanctions wall" - erected by Trump's hawkish advisers to block Biden's return to the deal – as pressure to compel Iran to make concessions on its nuclear program or other issues. But, as Rebel Alliance Admiral Gial Ackbar from Star Wars warned. "It's

"Biden may believe that he will look weak if he moves first. His advisers are likely angered by Iran's pressure tactics. They are also under pressure from some donors and conservatives in the Democratic Party, such as hawkish Senate Foreign Relations Committee Chairman Robert Menendez, to punish Iran," the publication says.

"The only certain path away from war is through a quick return to the agreement that prevented one," Responsible Statecraft asserted

Pointing to a recent Washington Post survey, Responsible Statecraft highlighted the majority of West Asia specialists insist the U.S. needs to rejoin the nuclear deal as soon as possible and noted, "75 percent of Middle East (West Asia) experts polled said that returning to the JCPOA would make it less likely that Iran would get a nuclear bomb in the next decade - about as certain a prediction as is possible in global security. Only 2 percent said that returning would make it more likely. Sixty-seven percent said that returning immediately to the deal before addressing other issues would serve U.S. national security interests. Only 23 percent wanted to go for a 'grand bargain' instead.'

and regional security negotiations"

Annalisa Perteghella, a research fellow at ISPI, believes that mending a transatlantic relationship is good but the EU should revise its policy in terms of facilitating the negotiations. The bloc should clarify that if the Biden administration keeps sanctions in place and links nuclear talks to broader regional security negotiations, it may jeopardize the chances of concluding a desirable nuclear deal and will likely spoil both processes.

ISPI stresses that the EU should offer its mediatory role under the condition of "an immediate, simultaneous, return to the JCPOA." The expert argues that consequently resolving the nuclear conflict would provide a platform for setting confidence-building measures. This will pave the way to negotiate regional security issues at the table, the expert adds.

On dos and don'ts of the three European parties to the JCPOA, RUSI, one of the most prominent think tanks all over the globe, has proposed some recommendations, too.

#### 'E3/EU should maintain a united front"

Aniseh Bassiri Tabrizi, a senior research fellow at the Royal United Services Institute (RUSI), stresses that E3/EU as a unified front of European states at the table "can incentivize talks between Iran and the U.S. and coordinate the process bringing the two parties back to compliance.'

The analyst with expertise in security and geopolitics of West Asia also writes: "They (E3/EU) will have a crucial role to play in hosting and choreographing an informal meeting between the current members of the Iran deal and the U.S. which could lead to an initial agreement."

Against this backdrop, RUSI underlines that Europeans should keep a united front to "take the initiative in areas where they can contribute - process and mediation, but also economic incentives '

Along with this, Bassiri Tabrizi points out that the unified European front should act step-by-step to reinstate the nuclear deal as the primary goal.

The analyst says this will lay the ground for broader talks including additional issues and actors.

France's proposal to play the role of a mediator in the JCPOA talks has raised broad discussions among the experts. In this regard, Clement Therme, a post-doctoral research fellow, at the School for Advanced Studies in Social Sciences (EHESS), has commented on the issue.

Leverage works two ways. Iran responded to each Trump move with its own moves and a dangerous cycle developed. On February 7, Iran's Supreme Leader Ayatollah Ali Khamenei said that Tehran's "final and irreversible" decision was to return to compliance only after the United States lifted sanctions. On February 23, Iran took another step away from the deal, implementing a law passed by Iran's parliament that will reduce the access of IAEA inspectors to some of Iran's facilities.

"The greatest danger of Donald Trump's Iran policy was that the two sides would stumble into a war that neither government wanted. Now the greatest danger of Joe Biden's policy is that the two sides could fumble away a deal that both governments actually want, Responsible Statecraft argues.

# Ex-Israeli generals, Mossad spymasters urge Biden's return to Iran deal

A group of former top officials from Israel's Atomic Energy Commission, the IDF and the Mossad sent a letter on Monday to Prime Minister Benjamin Netanyahu expressing support for a U.S. return to the 2015 nuclear deal with Iran, the Jerusalem Post reported on Tuesday.

Led by former IDF deputy chief of staff Matan Vilnai, commanders for Israel's security said in the letter that it "welcomes the American initiative to get Iran to again transparently follow the guidelines in the JCPOA as long as it includes an Iranian commitment to abide by UN Security Council Resolution 2231" regarding development of ballistic missiles

In addition to Vilnai, the letter was signed by former Mossad director Tamir Pardo, former IDF OC Operations Directorate Maj. Gen. Nitzan Alon, former National Security Council head Uzi Arad and Eli Levite, the former principal deputy director-general for policy at the Israeli Atomic Energy Commission.

The former senior defense officials expressed support for President Joe Biden's current position not to lift sanctions on Iran unless it returns to abide by the 2015 deal. The first goal needs to be to get Tehran back into compliance and then to work on a follow-up deal that would fill the holes in the JCPOA, they said.

Iran has been insisting that it is still a party to the nuclear deal and it is the U.S. that quit the agreement and naturally it is Washington that must return to its obligations under the agreement. Officials in Tehran have said it will reverse its remedial measures in reducing nuclear commitments if sanctions are fully lifted in practice and not in words.

"This will take into account new information that has been accumulated since the JCPOA, as well as additional problems that Iran presents," the letter said.

It was not the first time that the group has come out against Netanyahu's efforts to stop the JCPOA. Ahead of the signing of the 2015 deal, the group called on the prime minister to cancel his speech to the U.S. Congress.

At that time, former Mossad deputy director Amiram Levin said while it was difficult for him to speak out against Netanyahu, who served under him in the IDF, the prime minister's navigation was off.

"Leaders speak privately, not out in the open," he said. "The visit and the speech are exactly the opposite of that."

"Rather than working hand in hand with the U.S. president, we are going there and sticking our thumb in his eye," Levin said. "That not only hurts the president, but above all, it hurts the citizens of the U.S., who [while they] are fans of Israel, are first and foremost Americans.

Iran remained fully loyal to the nuclear deal for a full year despite the fact that Donald Trump, who had struck a close relationship with Netanyahu, ditched the pact in May 2018 and imposed sanctions against Iran in line with his administration's "maximum pressure" campaign against

Tehran.

However, in May 2019 Iran announced that its "strategic patience" is over and started to gradually remove bans on certain aspects of its nuclear activities. At the time Iran announced that if the remaining members of the JCPOA, especially the European trio (E3) protect Iran from the U.S. sanctions it will reverse its decision. But Iran saw no practical action.

Exasperated over inaction by the JCPO parties, the Iranian parliament also approved a legislation a few months ago obliging the government to speed up nuclear activities if sanctions are not lifted within a specific period of time. The legislation tasked the government to increase uranium enrichment to 20 percent, install advanced centrifuge machines and limit IAEA inspections of Iran's nuclear sites.

Iran began enriching uranium to 20 percent on January 4. It also started limiting IAEA access to nuclear facilities on Tuesday (Feb. 23). According to parliamentary law, the inspections will take place only based on the Safeguards Agreement.

Even now that Iran has suspended the voluntary implementation of the Additional Protocol it will continue to "implement fully and without limitation its Comprehensive Safeguards Agreement with the IAEA as before," the IAEA and the Atomic Energy Organization of Iran (AEOI) said in a joint statement on Sunday.

# Iran, South Korea close to unlocking frozen assets

**POLITICAL TEHRAN** – After months s k of a bitter dispute over Iranian assets frozen in South Korean banks due to the United States sanctions, Tehran and Seoul seem to be inching towards an agreement on unblocking the assets.

Iran has announced that it reached a deal with South Korea on how to release its assets blocked in South Korean banks. Abdolnasser Hemmati, governor of Central Bank of Iran (CBI), met with South Korean Ambassador to Iran Ryu Jeong-Hyun on Monday.

Following the meeting, state news agency IRNA reported that at the meeting, the necessary agreements regarding the transfer of assets to the intended destinations were made and the South Korean side was informed of the decisions of the CBI regarding the volume of transferred assets and the destination banks.

The South Korean ambassador expressed his country's readiness to facilitate the unblocking of Iranian assets.

"The country is ready to take all necessary measures to use all of Iran's banking assets in South Korea, and there are no ceilings or restrictions in this regard," Jeong-Hyun was quoted as saying by IRNA.

Hemmati welcomed the change in South Korea's approach toward Iran, adding that the Islamic Republic, although welcoming the increase of cooperation with other countries, retains the right to legally prosecute South Korea and demand compensations from it for not cooperating with Iran over the past two years.

"The [South] Korean side must do its utmost to erase this bad precedent," the CBI governor noted.

South Korea was quick to offer an explanation of what happened during the Monday meeting between Hemmati and Jeong-Hyun.

South Korea's Foreign Ministry said on Tuesday that the Iranian assets locked in South Korea will be released after consultations with the United States, Yonhap News Agency reported, without denying Iran-South Korea



negotiations over unblocking the assets. Our government has been in talks with Iran about ways to use the frozen assets, and the Iran side has expressed its consent to the proposals we have made," the South Korean Foreign Ministry told Yonhap News Agency.

"The actual unfreezing of the assets will be carried out through consultations with related countries, including the United States," the ministry continued.

According to Yonhap, earlier this month a South Korean Foreign Ministry official said Seoul was finalizing talks with Washington about using some of the frozen funds to pay Tehran's UN dues in arrears, to which the Islamic republic has also agreed. To facilitate the trade with Iran of humanitarian items, such as medicine and medical equipment, South Korea has been seeking to use a Swiss channel backed by the U.S., known as the Swiss Humanitarian Trade Arrangement (SHTA), to use the money through Swiss companies' sales of goods to Iran, the news agency added.

Tehran and Seoul have been locked in a bitter dispute over Iran's blocked assets in South Korea, with the seizure of the South

Korean ship in early January being the latest in a series of disagreements between the two Asian countries. Some 7 billion dollars of Iranian oil revenues have been frozen in two South Korean banks since September 2019, when Washington's sanctions waiver for South Korea's imports of Iranian oil expired.

In January, Yonhap claimed that Iran was seeking to use its money frozen in South Korea to buy medicine.

Citing a diplomatic source in South Korea, Yonhap claimed that Iran made a request to South Korea for the use of the frozen money to purchase medicine, medical equipment and COVID-19 vaccines from the COVAX Facility, a global vaccine procurement mechanism.

The issue of Iran's funds was one of the main issues that were discussed during South Korea's First Vice Foreign Minister Choi Jong-kun's visit to Tehran in January.

A few weeks after the visit, Iran proposed paying its UN membership fees with its seven billion dollars frozen in South Korea.

"We should have paid \$16 million to settle our debts to the UN and secure our right to vote. The government allocated the fund and urged that the country's frozen assets in South Korea be used [to pay the debts], but the U.S. blocked the payment to the UN account," Iranian Foreign Minister Moham-

mad Javad Zarif said in January. At that time, Saeed Khatibzadeh, spokesman for Iran's Foreign Ministry, also echoed the same proposal. Khatibzadeh said, "Iran's latest proposal in this regard was to pay this debt by having the UN use Iran's seized assets in South Korea with the permission of the central bank, which is being discussed with the UN Secretariat and the necessary arrangements are being made.'

Iran and South Korea appear to be moving toward settling the thorny issue of Iran's assets after a few rounds of failed negotiations in January. They are eager to find a solution to the issue. Over the past few months, both of them had proposed a number of solutions none of which broke the deadlock over the assets.

During the January negotiations, South Korea proposed to barter the whopping \$7 billion of Iran's assets blocked in South Korean banks for ambulance vehicles and coronavirus test kits, a proposal decried by Iran as "shameless."

During his visit to Iran, Jong-kun met with Iran's central banker to discuss how to release the Iranian assets. According to Iranian media, the South Korean diplomat proposed to provide Iran with ambulances and coronavirus test kits using Iran's assets. But Iran rejected the offer, saying that it wants to use the money to purchase foods and medicines. Iran also said that the Korean proposal did not include the release of all Îran's frozen assets.

With the negotiations still going on, Teh-ran and Seoul seem to be in the final stage of resolving the assets issue given South Korea's close contacts with the Biden administration, which has promised to rekindle diplomacy with Iran by reviving the 2015 Iran nuclear deal, formally known as the Joint Comprehensive Plan of Action (JCPOA).

# U.S. return to JCPOA only way out of nuclear impasse, China says


POLITICAL TEHRAN – China's Foreign Ministry e s k has said that the United States' return to the 2015 Iran nuclear deal is the only way out of the standoff over Iran's nuclear issue.

Chinese Foreign Ministry spokesperson Wang Wenbin called on the U.S. to rejoin the nuclear deal - officially known as the Joint Comprehensive Plan of Action (JCPOA)-, adding that the U.S. reentry into the JCPOA is the only solution to the current deadlock over Iran's nuclear issue.

Speaking at a press conference on Monday, the spokesperson said, "China holds that the return of the United States to the JCPOA is the only correct approach to resolve the impasse on the Iranian nuclear issue.

He added, "All parties should act with greater urgency, work together to implement consensus reached at the foreign ministers' meeting last December, and bring the JCPOA back on track at an early date. Meanwhile, we urge relevant parties to remain calm and exercise restraint, avoid taking actions that will escalate the situation, and leave room for diplomatic efforts.'

The spokesperson also welcomed the recent deal between



Iran and the International Atomic Energy Agency (IAEA) on how to continue cooperation between Tehran and the UN nuclear watchdog.

"The IAEA and Iran reached a technical plan on the verification and monitoring activities that is feasible and acceptable to both sides. China welcomes and commends

this and hopes that the two sides continue to work toward the same direction and earnestly follow through on this consensus. We also call on relevant sides to play a constructive role in this process," he said.

The Chinese Foreign Ministry also announced that Deputy Foreign Minister of Iran Seyed Abbas Araghchi held a telephone conversation with his Chinese counterpart Ma Zhaoxu on Monday, according to Fars News.

The Chinese Foreign Ministry issued a statement saying that Beijing and Tehran believe that the U.S. return to the JCPOA and the lifting of sanctions are the key to resolving the nuclear deadlock. The statement also said that the two diplomats mainly discussed the situation around Iran's nuclear program.

During the conversation, Araghchi and Zhaoxu underlined hat the situation of Iran's nuclear issue is changing rapidly and there are opportunities and challenges at the same time. The Iranian and Chinese deputy foreign ministers called

on the parties to the JCPOA to use this opportunity to resolve the Iran nuclear issue politically and diplomatically and to maintain peace and stability in West Asia.

# Iran halts implementation of Additional Protocol

 $1 \rightarrow$  "As of 12:00 p.m. local time (2030 GMT), we have nothing called obligations beyond the Safeguards Agreement," the ambassador said. "Necessary orders have been issued to nuclear facilities."

Iranian Foreign Minister Mohammad Javad Zarif also announced the cessation of implementation of the Additional Protocol on Tuesday

Speaking on the sidelines of an international conference in Tehran on Tuesday, Zarif said, "We have officially announced to the International Atomic Energy Agency since February 15 that the Parliament's law on this issue will be implemented from the morning of February 23, and for this reason, the implementation of this law has started this morning.<sup>2</sup>

The nuclear law, officially called "Strategic Action to Lift Sanctions and Protect the Nation's Rights," stipulates that the Iranian government should take certain nuclear measures such as raising the level of uranium enrichment to 20% and suspending the voluntary implementation of the Additional Protocol in few months if the Western parties failed to honor their obligations under the 2015 Iran nuclear deal, formally called the Joint Comprehensive Plan of Action (JCPOA).

The sixth article of the law clearly stipulates that if the remaining parties to the JCPOA - Germany, France, China, Russia and the UK- failed to facilitate Iran's oil exports and the return of Iranian oil revenues in two months, the Iranian government would be obligated to stop inspections beyond the IAEA safeguards, including the voluntary implementation of the Additional Protocol, which allows unannounced and intensive inspections of nuclear sites.

Zarif also pointed to the recent visit by

the IAEA director-general, Rafael Grossi, to Iran, saying that the UN nuclear watchdog chief came to Iran to make arrangements for the implementation of the nuclear law.

"Mr. Grossi came to Iran to make arrangements for the implementation of the law. We have reached an agreement in this regard, and the principle of this agreement is that the tapes recorded from our nuclear programs, which were never presented live to the Agency, but were provided on a daily and weekly basis, will be kept from now on and will not be presented to the Agency," the chief Iranian diplomat said, noting that Iran will continue to implement the IAEA safeguards.

On Sunday, Zarif met with Grossi in Tehran to discuss issues related to the nuclear law.

"Collaborations between Iran and the IAEA, the Agency's efforts to settle the two sides' issues, and the cooperation between Tehran and the UN nuclear watchdog within the framework of the Safeguards Agreement were among the most pressing issues discussed by the Iranian foreign minister and the IAEA director general," Iran's Foreign Ministry said in a statement following the meeting.

During his two-day visit, the IAEA chief struck a deal with Iran on how to continue cooperation between Iran and the Agency in light of the nuclear law.

"Intensive consultations led to a good result. A temporary technical understanding has been reached. The IAEA will continue its necessary verification and monitoring in Iran," the UN nuclear watchdog chief said in a tweet following his visit to Iran.

The IAEA and the AEOI issued a joint statement outlining the content of the understanding moments after Grossi concluded his visit to Iran.

"The Atomic Energy Organization of Iran (AEOI) and the International Atomic Energy Agency (IAEA) recalled and reaffirmed the spirit of cooperation and enhanced mutual trust that led to the Joint Statement in Tehran on 26 August 2020, and the importance of continuing that cooperation and trust," the statement said. "The AEOI informed the IAEA that in order to comply with the act passed by the Parliament of the Islamic Republic of Iran called "Strategic Action to Cease Actions and Protect the interest of Iranian Nation" (The "Law") Iran will stop the implementation of the voluntary measures as envisaged in the JCPOA, as of 23 February 2021.'

The statement added, "In view of the above and in order for the Agency to continue its verification and monitoring activities, the AEOI and the IAEA agreed: 1. That Iran continues to implement fully and without limitation its Comprehensive Safeguards Agreement with the IAEA as before. 2. To a temporary bilateral technical understanding, compatible with the Law, whereby the IAEA will continue with its necessary verification and monitoring activities for up to 3 months (as per technical annex). 3. To keep the technical understanding under regular review to ensure it continues to achieve its purposes.

The deal was reached only two days before Iran started implementing the nuclear law. The deal drew criticism from some Iranian lawmakers who accused the government of circumventing the nuclear law. But the government reassured them that the deal with the Agency was in line with the nuclear law.

"The result of what happened during Mr. Grossi's visit between Iran and the International Atomic Energy Agency is a remarkable diplomatic and technical achievement. Dr.



Salehi and his colleagues worked hard to move within the framework of the parliament's binding law. As stated in the joint statement with the IAEA, all that has been agreed is in accordance with parliamentary law," Saeed Khatibzadeh, spokesman for Iran's Foreign Ministry, said at a press conference on Monday.

Gharibabadi also offered assurances to the lawmakers that the deal is consistent with what the Parliament had enacted.

"The Agency will not be given any access beyond the [IAEA] safeguards. The continuation of the Agency's verification, as per the technical annex to the Joint Statement, is solely for the purpose of maintaining information on certain activities and monitoring equipment by Iran for three months. The Agency has no access to this information and the information remains exclusively with Iran. If the sanctions are lifted completely within three months, Iran will provide this information to the IAEA, otherwise, it will be deleted forever," Gharbibadi tweeted on Sunday night.

The nuclear law is part of Iran's strategy to force the West into lifting sanctions. Iran has said many times that it will return to the full implementation of the 2015 nuclear deal after the U.S. lifts its sanctions.

# **Beiranvand has suffered** thigh injury: Vercauteren

S P O R T S TEHRAN — Antwerp Coach Franky Vercauteren says that Iranian goalkeeper Alireza Beiranvand has sustained a thigh injury.

Beiranvand had to limp off against Rangers after overstretching for a save, but he had recovered enough to play in their weekend goalless draw against St. Truiden.

However, the luckless keeper injured a thigh muscle and had to be taken off for the second game in a row to be replaced by on-loan Eupen keeper Ortwin De Wolf again.

"It's a different injury than the one he got against Rangers in the first leg. The first injury was an adductor muscle strain and this one happened at the top of his thigh," Vercauteren said.

It's pure coincidence and his bad luck he had to leave two games in a row through injury. "It's unlikely he will be ready for Glasgow, but we will give him

every chance," he added.

Iran expects to reap a bonanza from its numerous tourist spots such as bazaars, museums, mosques, bridges, bathhouses, madrasas, mausoleums, churches, towers, and mansions, of which 24 being inscribed on the UNESCO World Heritage list.

Under the 2025 Tourism Vision Plan, it aims to increase the number of tourist arrivals from 4.8 million in 2014 to 20 million in 2025. So it will undeniably try its best to achieve a relatively ambitious goal but when that happens the travel industry is likely to look more altered.

# Virus causes \$5.2 billion damage to Iran's tourism, minister says

 $\rightarrow$  1 If the budget receives parliament's approval, it will be injected into different sectors of the tourism industry, which has taken a major hit from the coronavirus outbreak over the previous months, he noted.

Despite the toughest economic pressures and sanctions, the government has provided good support to all sectors of tourism, the minister said. However, there is hope that the beginning of mass vaccination against the coronavirus will provide better conditions for tourism and businesses related to this sector, he explained.

# We have gained permission for limited New Year travels: deputy tourism minister

**TOURISM TEHRAN** – Iran's Cultural Heritage, Tourism and Handicrafts Ministry has gained official permission for organizing limited intercity travels during the Iranian New Year vacations, which begins on March 21.

"We have obtained permission for limited Noruz trips from the National Headquarters for Coronavirus Control," the deputy tourism minister, Vali Teymouri, announced on Tuesday.

With less than a month to go till the start of the Iranian New Year, which has long been associated with millions of domestic travels, the ministry wants to find a way to partially revive the already-slumped travels in the face of the COVID-19 pandemic.

"The tourism ministry has held several meetings with the National Headquarters for the Coronavirus Control during with we discussed the issues in detail. Based on our strategies, we proposed two travel models that can be implemented following health protocols in the country," Teymouri said last week.

The first [working] model for travels in the Iranian New Year, proposes travels by the means of package tours. "Throughout package tours, travelers benefit from services provided by the tour and they will stay in authorized accommodation centers [and destinations] which are under the supervision of



the Ministry of Cultural Heritage, Tourism and Handicrafts," the official explained.

For the second model, people do not go on tours, but when traveling to their destination city, they must stay in authorized accommodation centers, which are under the supervision of the ministry, to comply with all health protocols and maintain public health, Teymouri stated.

Any other form of accommodation would be prohibited to curb the virus, he said. "To help prevent the spread of the coronavirus in Noruz 1400, the establishment of tourist camps, camping, tourists staying in places such as schools, shrines, husseiniyahs, etc. is prohibited, and this issue has been announced to the provincial governors."

The arteria of Noruz travels is expected to be announced in detail during the upcoming exhibition for tourism and handicrafts, which will be held in near future, according to the official.

The tourism minister, Ali-Asghar Mounesan, publicized in November that mass, unplanned travels are not approved. "The outbreak of the coronavirus has caused damage to the tourism industry in Iran and [other parts of] the world in such a way that according to statistics, 50 million people are directly and indirectly exposed to unemployment due to the virus spread in the global scene.... yet, mass or unplanned and irresponsible travels are not approved to take place during the coronavirus era."

Smart and responsible traveling should replace "do not travel" recommendations, the minister stressed, adding: "In our country, Corona has caused problems in the tourism industry and the worrying point is the continuation of this trend."

"We are well aware of what the National Headquarters for Coronavirus Control proclaims [the health protocols], hence as a proposal, we have formulated some smart, responsible travel packages by the implementation of which we could have secure travels," the minister said.

He has repeatedly announced that his ministry is in full coordination with the Ministry of Health for strictly implementing health protocols in travel destinations, hospitably centers, and museums, amongst others, underlining that "people's health is our priority."

Iranians traditionally make hundreds of thousands of domestic trips during the New Year holidays, when most businesses and workplaces are closed, as are schools.

# Moazzenzadeh Ardebili's ancestral house to be turned into museum

#### Government's care and support packages

In late October, the deputy tourism minister, Vali Teymouri, announced that a new support package to pay loans to businesses affected by the coronavirus pandemic has been approved.

Depending on the type and activity of the businesses, they could benefit from at least 160 million rials (\$3,800) to nine billion rials (\$214,000) of bank loans with a 12-percent interest rate, he said.

The loans will be allocated to tourist guides, travel agencies, tourism transport companies, tourism educational institutions, eco-lodges and traditional accommodations, hotels, apartment hotels, motels, and guesthouses as well as traditional accommodation centers, tourism complexes, and recreational centers, the official explained.

Teymouri pointed to the 1.3 million tourism workers in the country, who are facing several issues due to the coronavirus crisis, and said "This number, in addition to their households, includes a significant population that makes a living through tourism, who are needed to be considered in ministry's decisions."

Teymouri has said that the tourism ministry has approved a total budget of 4,920 billion rials (over \$117 million) to support corona-affected tourism businesses, covering as much as 36,000 people working in the tourism sector.

"A consortium consisting of banks and active holdings in the country is being formed to implement the [already-formulated] comprehensive development plan of Hondurabi," Mozaffari said.

"Kish Island, even during coronavirus pandemic, has enjoyed a tourism boom... [for instance] in the last two months, its occupancy rate of hotels has been 98 percent, which indicates the unique tourism capacity of the region."

# Botulism kills 10,000 birds in Miankaleh peninsula, Gorgan Bay

ENVIRONMENT d e s k 10,000 bodies of lifeless migratory birds died as a result of botulism poisoning have been found so far around the Miankaleh peninsula and Gorgan Bay, located in the extreme south-eastern part of the Caspian Sea.

Botulism disease, which for the second consecutive year has caused the death of a large number of migratory birds in Miankaleh and Gorgan Bay, has reached Ashuradeh Island, IRNA reported on Tuesday.

Botulism is caused by a toxin produced by the bacterium Clostridium botulinum, and the birds become infected by the ingestion of plants or animals infected with the toxin and lose their lives.

Clostridium botulism is an anaerobic bacterium that grows in decaying plants and animal material and often occurs in lakes during periods of lack of oxygen and poor water quality.

The carcasses were mostly from bird species of flamingo, coot, duck, and pelican, which have been discovered around the shores of the Bandar Torkaman city, Ali Bayani, head of the provincial department of environment said.

In January 2020, media reported the mysterious death of over 40,000 migrato-



ry birds in the Miankaleh peninsula; a week later, the veterinary organization announced that "botulinum poisoning" was the reason behind mass bird mortality.

Management 'out of control' Excessive hunting in migratory birds' habitats in the country has made the Con-

vention on Migratory Species warn some

countries about this issue, which has always been a global threat to biodiversity and has attracted international attention.

Now, along with illegal hunting, there are other environmental threats, including water pollution and wastewater flow, lack of provision of wetlands' water right, cause the management of migratory birds' habitats

#### to get out of control. A treasure under threat

The long and narrow peninsula is 48 kilometers long, and between 1.3 and 3.2 kilometers wide, which sets apart the Gorgan Bay from the Caspian Sea. Four villages namely Ashuradeh, Qezel-e Shomali, Qezel-Mehdi, and Qavasatl are situated on the peninsula.

Miankaleh was designated a Ramsar site in 1975. Major habitats include wetlands, inter-tidal mud with sandy shores, shallow marine waters, forests, peatlands, and agricultural areas.

It is home to many unique Caspian birds and reptile species native to this region. It's also a very important internationally-recognized refuge for migratory birds.

The peninsula water deficits, additionally mismanagement, unsustainable agricultural practices, and severe depletion of the wells and groundwater resources have exacerbated the Miankaleh peninsula's condition.

Local people earn their income from agriculture, horticulture, animal husbandry handicrafts, carpet weaving, traditional poultry farming, and tourism.

Overgrazing, illegal hunting, fishing, deforestation, and the unplanned spread of villages are some of the challenges posing threat to the region's environment.



# Over 6,700 nomadic schools operating across Iran

Each year, Iranian students start the school year on September 23, after three-month summer vacation, while this year, in the light of the coronavirus pandemic, all educational centers in Iran have been closed since late February 2020, and education was followed in three forms of in-person, virtual, and television-based

In order for students to keep in touch with their studies, the Ministry of Education launched a homegrown mobile application on April 9, called SHAD, providing students with distance learning programs. He added that more than 60 percent of students and 94 percent of teachers attended 64

percent of classes through the SHAD app, whose acronym in Persian translates as the Students Education Network. Moreover, the Islamic Republic of Iran Broadcasting (IRIB) also began to broadcast televised educational pro-

grams on a daily basis after school closures. The National Headquarters for Coronavirus Control announced that schools with less than 50 pupils and

vocational schools are allowed to start operating for practical and workshop courses in accordance with the health protocols, while the students' presence is voluntary and on their choice.

# Japan, WFP support refugees in Iran

**OCIETY TEHRAN** – The Government of Japan ber ernment of Japan has contributed \$875,000 to support refugees in Iran through the United Nations World Food Program (WFP).

This contribution supplements a grant of \$7 million in March 2020 to support the WFP COVID-19 response in Iran. This contribution will be utilized to purchase wheat flour, pulses, and oil for the most vulnerable refugees living in settlements in Iran.

"We're extremely grateful for the Government and people of Japan for their continued support to our operations in Iran," said Negar Gerami, WFP Representative in Iran. "Refugees are the most vulnerable group in a society and they need support now more than ever to recover from the effects of the COVID-19 pandemic.'

WFP currently supports 31,000 destitute Afghan and Iraqi refugees living in 20 settlements across the country with food, education, and livelihood assistance.

Kazutoshi AIKAWA, Ambassador of Japan to Iran, said that "supporting refugees is one of the priority areas of the Japanese Official Development Assistance to Iran. The spread of COVID-19 in Iran has definitely affected the living situation of vulnerable groups, including refugees. The Government of Japan recognizes that the cooperation with WFP in Iran, which has continuously supported the food and sanitation of refugees in Iran, is effective in order to sustain the lives and livelihoods of the refugees in constantly

worsening conditions."

Iran has been hosting one of the largest refugee populations in the world for well

over three decades. Two million foreign nationals residing in Iran

Deputy Interior Minister Javad Naserian said last week that about one million documented foreign nationals are residing in Iran, and perhaps another one million are illegally living in the country.

At the end of 2018, Iran hosted close to one million refugees, making it the sixth-largest refugee host country in the world. The country was also the eighth largest refugee-hosting country in the world in 2019, hosting 951,142 Afghan refugees and 28,268 Iraqi refugees, according to the UNHCR.

One of the largest and most protracted urban refugee populations in the world is living in Iran; about 97 percent of refugees live in urban and semi-urban areas, while three percent are residing in 20 refugee resorts run by the UNHCR's main government counterpart.

Undocumented Afghans have access to free primary health services and similarly free COVID-19 related testing, treatment, and hospitalization, just like nationals.

In Iran, UNHCR is seeking \$16.2 million for its COVID-19 emergency, while requires an additional \$98.7 million to support Iran in maintaining and sustaining its commendable inclusive refugee policies, under the umbrella of the Solutions Strategy for Afghan Refugees.

# Some \$3.4m of smuggled goods seized in week

**SOCIETY TEHRAN** – Goods worth 146 billion e s k rials (nearly \$3.4 million at the official rate of 42,000 rials) have been seized from smugglers in the country over the past week, police chief Mohammad Reza Moghimi has announced.

With these measures, the condition has become completely unsafe for the smugglers, Moghimi further stated. Due to the necessity and sensitivity of providing basic

and health-oriented goods, confronting and combating the smugglers of goods and currency is vital, and this is seriously pursued by the police throughout the country, he explained.



During the last week, all kinds of smuggled goods, including mobile phones, home appliances, Bitcoin miners, spare parts, currency, and cosmetics, were discovered in the country with the specialized measures and round-theclock efforts of the anti-trafficking police, he stated.

The discovered goods were handed over to the Organization for Collection and Sale of State-owned Properties, and 6 smugglers were arrested and handed over to the judicial authorities, he said, IRNA reported on Tuesday. Smugglers fined \$570m in 8 months

From the beginning of the current Iranian calendar year (March 21, 2020) until November 16, 2020, smugglers of fuel and livestock were fined 24 trillion rials (about \$570 million), representing a 47 percent increase compared to the same period last [Iranian calendar] year.

Out of a total of about 42,000 smuggling cases, about 28,000 were related to export smuggling, of which 20,000 were related to the smuggling of fuel and petroleum products, mostly to Pakistan and Afghanistan, and to a lesser extent to Turkey and Iraq. A number of these cases were related to livestock traf-

ficking. Most of the cattle were smuggled to Iraq, and then to the Persian Gulf countries.

Every year, \$20-25 billion are smuggled in and out of the country, which, if stopped, will create hundreds of thousands of jobs, Hassan Norouzi, a member of the parliament, said.

In the Iranian calendar year 1396 (March 2017-March 2018), \$12 billion was smuggled into Iran and \$900 million out of the country, according to the Headquarters for Combating the Smuggling of Commodities and Foreign Exchange

Iran, which has a 900-kilometer border with Afghanistan, has been used as the main conduit for smuggling Afghan drugs to narcotics kingpins in Europe.

Despite high economic and human costs, Iran has been actively fighting drug-trafficking over the past decades.

In June 2020, the first phase of the national anti-smuggling plan was implemented with the priority given to customs tobacco, and transit goods.

# Wetlands restoration requires a budget of **\$14b: DOE chief**

In order to restore wetlands in the country a budget of 600 trillion rials (nearly \$14 billion) is required, chief of the Department of Environment (DOE) Issa Kalantari said on Sunday. There are 80 big and small wetlands in the country and some are dried out, Kalantari regretted adding that last year (March 2017-March 2018) more than 20 trillion rials (nearly \$475 million) was allocated to wetlands restoration and the amount is projected to increase to 25 trillion rials (nearly \$595 million) for next fiscal year (starting on March 21), he said.

Some of the sand and dust storms originate from the dried bed of the wetlands and revival of these hotspots would help in decreasing sand and dust storms, he highlighted.

The ICEFA Lidice was established in 1967 to commemorate the child victims from the Czech village of Lidice murdered by German Nazis, as well as all other children who have died in wars.

Although national initially, this exhibition became an international one in 1973, and since then it has become well known among children and teachers not only in the country but literally all over the world.

In recent years, more than 25,000 very good works of art have come regularly by children not only from the Czech and Slovak but also from over 60 countries, including China, India, Japan, Kenya, Malaysia, the Philippines, Sri Lanka and Zimbabwe.

Landscape was the theme of the 2020 ICEFA Lidice, during which Iranian children Ratin Eteqad, Mahta Abed, Ali Ashrafi, Melisa Razavi, Azam Azimi and Shadi Esmaeilnia were honored in various categories of the exhibition.

Ratin won a medal in the painting section while Ali and Melisa received honorable mentions in the category.

Mahta received a medal in the photography section and Azam and Shadi won honorable mentions in this section.

# "Our Man in Tehran" by Robert Wright published in Persian

**CULTURE TEHRAN** – A Persian translation of Robert Wright's "Our Man in Tehran" has re-cently been published by Amirkabir Publications in Tehran.

'Our Man in Tehran: The True Story Behind the Secret Mission to Save Six Americans during the Iran Hostage Crisis and the Foreign Ambassador Who Worked with the CIA to Bring Them Home" has been translated into Persian by Mohammad Mozaffarpur.

Iranian students occupied the American Embassy in Tehran in November 1979. The Americans were caught entirely, and what began as a swift and seemingly short-lived takeover evolved into a crisis that would see fifty-four

embassy personnel held hostage, most for 444 days, the book says.

As Tehran exploded in a fury of revolution, six American diplomats secretly escaped. For three months, Ken Taylor, the Canadian ambassador to Iran, along with his wife and embassy staffers, concealed the Americans in their homes, always with the prospect that the revolutionary government would exact deadly consequences.

With limited intelligence resources available on the ground and anti-American sentiment growing, President Carter turned to Taylor to work with the CIA in developing their exfiltration plans. Until now, the true story behind Taylor's involvement in the escape of the six diplomats and the Eagle Claw commando raid has remained classified.

"In Our Man in Tehran", Wright takes readers back to a major historical flashpoint and unfolds a story of cloak-and-dagger intrigue that brings a new understanding of the strained relationship between the United States and Iran.

Wright, a Ph.D., is a professor of his-tory at Trent University, specializing in foreign policy. He is the author of "Three Nights in Havana", which won the 2008 Lela Common Award for Canadian History from the Canadian Authors' Association and is currently being made into a feature documentary. He resides in Toronto with his wife and children.

# Tehran hall to host theatergoers for Tennessee Williams' "Glass Menagerie"

**TEHRAN** – A reading performance of American playwright Tennessee Williams' memory play "The Glass Menagerie" will go on stage at Tehran's Jamshid Mashayekhi Theater on Saturday.

Romina Jahandideh will direct the play based on a Persian translation of the play by Hamid Samandarian, whose wife, Homa Rusta, staged it in 1972.

Shaahin Alinejad, Mojdeh Mohajeri, Narges Hashemi and Ali Barqbani are the members of the cast.

In "The Glass Menagerie", Tom recalls scenes from his youth during the height of the Depression. It shows his mother, Amanda, trying to maintain a lost gentility in the midst of overwhelming poverty and cajoling her children into her idea of happiness.

Tom also has a crippled older sister, Laura, who resembles her collection of glass animals in her delicate beauty and fragility. Tom works in a shoe factory to contribute

to the family's support while dreaming of becoming a poet. At his mother's insistence, he brings a friend from work home as a possible suitor for Laura. The suitor went to high school with Laura. He is the only boy that she has ever had a crush on.

The evening turns into a disaster. After Jim leaves, Amanda scolds Tom, who runs off to join the merchant marine shortly after that disastrous night. But, as Tom tells the audience, he was never able to leave his guilt behind. So, in the end, none of them escaped from the traps in which they were caught.

The play catapulted Williams from obscurity to fame. It has strong autobiographical elements, featuring characters based on its author, his histrionic mother, and his mentally fragile sister Laura.

In writing the play, Williams drew on an earlier short story, as well as a screenplay he had written under the title of "The Gentleman Caller".

The play premiered in Chicago in 1944. After a shaky start, it was championed by Chicago critics Ashton Stevens and Claudia Cassidy, whose enthusiasm helped build audiences so the producers could move the play to Broadway where it won the New York Drama Critics' Circle Award in 1945.

"The Glass Menagerie" was Williams' first successful play. He went on to become one of America's most highly regarded playwrights.

Earlier in 2017, Iranian director Mikail Shahrestani's troupe performed "The Glass Menagerie" at Tehran's Theater House.
